a. Personal Identification Information

- Full name
- Date of birth
- Gender
- Photograph
- Aadhaar number (with consent)
- PAN card, Voter ID, Driving License, etc.
- CKYC details

b. Contact Details

- Address (permanent and current)
- Email address
- Phone numbers

c. Financial Information

- Bank account details
- Credit history
- Income details
- Loan repayment data
- UPI and eNACH mandate data

d. Transactional and Usage Data

- Loan applications and repayment transactions
- Access logs and app usage statistics
- Location data (with permission)

e. KYC Data

- Captured only with explicit consent for onboarding or regulatory purposes

3. How We Use Your Information

We use your data to:

- Process loan applications and disbursements
- Verify identity and perform due diligence (as per KYC/AML guidelines)
- Create and maintain your customer profile
- Collect repayments and send reminders
- Facilitate eMandate (eNACH) and UPI payments
- Improve our services and ensure security
- Comply with regulatory and legal obligations
